Dear colleagues,

Much of last month's focus was on the increasing unemployment of Europe's youth. CEMR proposed some month ago the "EU Starter", an initiative addressing youth unemployment in our communities across Europe. CEMR and its member associations are indeed very concerned about the massive youth unemployment and the growing lack of perspectives and social tension. In this context, European Council President Herman Van Rompuy has invited EU leaders to come forward with ideas to foster youth employment.



With an open letter addressed to the heads of states and governments, we would like to ask you to propose the "EU-Starter" initiative as a concrete action for approval, ahead of the EU summit to be held on 27 and 28 June 2013. The initiative would offer a year of work experience to 1 million young Europeans in the public sector or in non-profit organisations. It would be financed notably by unused structural funds money and I strongly encourage you to support this initiative vis-à-vis your national government.

Among other activities during the last weeks, we have conducted a study on our members' different sources of funding. The research called "Sources of income: a glance at the budget of national associations" responds to a demand arisen from one of our association members. Today I am pleased to provide you with the results, that you will find in this newsletter. I hope this information will be useful in your future projects.

Qualitative evolution of partnership between EU and local & regional authorities in partner countries

We are happy to see that there has been a qualitative evolution in the nature of partnerships between the EU and local and regional authorities in partner countries. Indeed, thanks to PLATFORMA and CEMR's lobbying, the European Commission has recognised in its new communication⁽ⁱ⁾ the potential of municipalities and regions in implementing public policies in response to the dual challenge of the eradication of poverty and of sustainable development. Work remains to be done in ensuring that the communication is applied transversally to the whole of European development policy. Involvement of local and regional authorities in the preparation of Partnership Agreements

Committee of the Regions acknowledges CEMR contributions

The Committee of the Regions (CoR) has acknowledged the contribution of the CEMR to its report on “the Consultation on the involvement of local and regional authorities in the preparation of Partnership Agreements”. Based on a survey among our members, we provided evidence about the “Involvement of national associations of Local and Regional Authorities in the Partnership Agreement preparations”⁽ⁱ⁾. Among other things, our report shows that the degree of involvement of municipalities, regions and their national associations varies substantially from one member state to the other. Both CoR and CEMR reports intend to contribute to the European Commission’s own report of the application of the partnership approach, expected early 2014. In view of the upcoming renewal of our world organisation UCLG’s Executive Bureau and World Council, we would like to encourage our members, if you have not yet done so, to submit your nomination proposals for the European representation within these bodies before 20 June 2013. The World Council is UCLG’s main policy-making body – similar to CEMR’s Policy Committee – while the Executive Bureau is responsible for initiating proposals and implements Council decisions. Ahead of the EU summit to be held on 27 and 28 June 2013, we would like to encourage you to promote our proposal “EU Starter” vis-à-vis your national government, as it would offer a year of work experience in a public institution or non-profit organisation to 1 million young Europeans. This would help kick-start the fight against youth unemployment and ensure that the unspent European Social Fund money be used to fund concrete youth employment actions. Position paper on waste

Creating a resource efficient society must be a shared responsibility

A second position has been adopted on waste⁽ⁱ⁾ in the framework of the EU waste legislation reform. It notably expresses CEMR's reluctance when it comes to reviewing EU targets on waste, which falls upon local authorities, such as preparing for the re-use and recycling of waste. CEMR insists that more attention needs to be paid to the early stages of production and packaging, as some products could use less or different types of wrapping, while others could be produced in more limited quantities.
