By the end of 2013, the European Commission will be finalising negotiations on Partnership Agreements and Operational Programmes of the cohesion policy for the 2014-2020 programming period. The new cohesion programmes provide new instruments for territorial development.



One of the key questions is the cooperation between cities or municipalities and their surrounding local authorities and how these initiatives will be promoted by the EU policies between 2014 and 2020. CEMR and its members support this strongly. With the purpose to exert influence in the negotiations, we have published a survey notably exposing benefits for urban and rural areas to collaborate. More information about the study is available in this newsletter.

This month I am pleased to announce the candidacy of the president of AFCCRE and mayor of Bordeaux, Alain Juppé, to the co-presidency of our world organisation UCLG for the 2013-2016 mandate. His candidacy has unanimously been endorsed by CEMR and European members of UCLG. His appointment will be confirmed at UCLG's Congress in October 2013 in Rabat.

### Public procurement

#### Political agreement reflects CEMR position on public-public cooperation

Thanks to a strong joint lobbying of CEMR and its members, the political agreement on the concessions and public procurement directives reflects our position on public-public cooperation. The new agreement will allow municipalities to transfer the delivery of a public service task to another local authority on the basis of mutual agreement and without any obligation in return. The agreement was achieved on 25 June 2013 and should be adopted by the Parliament and the Council in October. Major changes are not expected. ### **CEMR meets President Barroso to discuss youth unemployment**

During this meeting held on 6 June 2013 in Brussels, the mayor of Venice and vice-president of CEMR, Giorgio Orsoni, urged the Commission to take into account the local and regional recommendations to reduce 5.7 million of young people unemployed. For this purpose, he called the Commission to back the EU Starter [i](#) initiative, which aims at integrating 1 million young people into the labour markets through local and regional governments. ### State aid

#### **“Less bureaucracy for small financial aid” underlines CEMR in a consultation**

CEMR has responded to the consultation on the *de minimis* regulation [\(i\)](#). In this document we defend that local services should be, in general, exempt from EU State aid rules unless the Commission can prove that a local service has an impact on competition and trade in the EU internal market. In the context of the crisis, we also warn the Commission that it is not the appropriate time to limit public authorities' possibility to grant aid aiming to create and safeguard jobs.
