# Declaration

## on the European Commission's Opinions on Georgia, Republic of Moldova and Ukraine's application for membership in the European Union

1. The European Commission recommends giving Georgia, Moldova and Ukraine **the perspective to become members of the European Union. The Commission also recommends granting candidate status to Ukraine and Moldova, and to Georgia once several priorities have been addressed.**
2. The European Commission's opinions underline the importance of the decentralisation process and public administration reforms in the three countries, as key components of the political criteria for EU membership.
3. The Council of European Municipalities and Regions (CEMR), together with PLATFORMA, have provided support to their members, the national associations of local and regional governments in the EU Eastern neighborhood, in strengthening local autonomy, institutional capacity and fostering multilevel governance reforms.
4. The CEMR has been facilitating the capacity-building of local and regional governments and their representative associations for sustainable local development and reinforcing decentralised cooperation with local governments in Georgia, Moldova and Ukraine.
5. The CEMR is ready to continue to underpin its member associations from Georgia, Moldova and Ukraine in their contribution to the EU membership process. In particular, CEMR will continue to back Local Governments and their National Associations to localise the EU (e.g., Associations Agreements, EU-Eastern Partnership policy agenda, Green Deal) and Global agendas (e.g.; localising Sustainable Development Goals, Paris Agreement).
6. In this context, CEMR commits to defending a *Trio* holistic approach and considers that the **European Council should grant EU candidate status to Ukraine, Moldova and Georgia** - to retain coherence of the Eastern Partnership's existing policy.
7. The CEMR insists on the **important role of decentralised cooperation** (e.g., peer exchanges, municipal partnerships, mentorship, study visits, twining, seminars, trainings) to accompany the needed institutional reforms and ensure a sustainable integration process. Notably, to overcome socio-economic difficulties, in the emergency and recovery phases of the **post-COVID-19 coronavirus pandemic and post-war in Ukraine.**
8. Granting candidate status to the three countries will have a significant impact on the consolidation of the local democracy, local autonomy and decentralisation reforms crucial for the three countries' long-term sustainable development. It would also allow local governments to have their specific rights and be better equipped with technologies, practices, administrative and financial tools for this important responsibility.
9. In the upcoming membership negotiations, CEMR hopes that these aspects will be taken into consideration by the European institutions and competent authorities in support of the candidate status of Ukraine, Moldova and Georgia to the European Union.
10. The text of the declaration will be adopted by CEMR Policy Committee which takes place in Bologna on 4-5 July.
